

2. The Squad shall keep vigil, oversight and carry out patrolling functions. Further, the squad shall be kept mobile, alert and active at all times and shall be empowered to inspect places of potential ragging and make surprise raids on hostels and other hot-spots, if any. The squad shall investigate the incidents of ragging and make recommendations to the Anti-Ragging Committee and shall work under the overall guidance of the Anti-ragging Committee. All matters of discipline within the teaching institutions must be resolved within the campus except those impinging on law and order or breach of peace or public tranquility, all of which shall be dealt with under the penal laws of the land.

3. The committee constituted above, shall meet at least once in a year to recommend preventive measures that can be adopted by the Institute to prohibit, prevent and eliminate the menace of ragging in any form on the Campus of the Institute.

4. The Anti-ragging squad shall submit a weekly report to the undersigned.

5. The Committee constituted as per Office order cited first stands modified to the above extent and shall come into force from the date of this order.
