Sub :- PKDIMS- reconstitution of the Pharmacovigilance Committee – orders issued

Ref :- Order No. PKDIMS/COMMITT/PRNPA/2021-22/4 dated 17.05.2022

As per the Guidelines of National Medical Commission, it is essential to constitute Pharmacovigilance Committee (PvC) to oversee various Pharmacological aspects of Drug administration & subsequent patient compliance in a Teaching Hospital wherein Medical College is established. Every medical college of the country should have a functional Pharmacovigilance committee.

The broad goal of the Committee is to generate awareness about the need of identifying & reporting of Adverse Drug Reactions (ADR), amongst all sections of health care providers of PKDIMS and to identify ADR occurring in patients admitted to the Institution and report the same to the appropriate authorities.

Objectives of PvC :-

- To create awareness amongst health care professionals and students of the Institution about the importance of ADR reporting.
- To monitor benefit-risk profile of medicines.
- Generate independent, evidence based recommendations on the safety of medicines.
- Support the Central Drug Standard Control Organization (CDSCO) for formulating safety related regulatory decisions for medicines.
- Communicate findings with all key stakeholders.
- Promotion of research based on Pharmacovigilance
