ORDER

 The Fee Regulatory Committee, hereinafter referred to, for short, the Committee, by orders referred to as 1st paper to 3rd papers above, has regulated the tuition fee and other fees in respect of P K Das Institute of Medical Sciences, Vaniyamkulam, Palakkad, hereinafter referred to, for

short, the Medical College for the academic years 2021-22, 2022-23 & 2023-24. Details of the tuition fee and other fees fixed by the Committee are given below:

2. In the meanwhile, the Medical College approached the Hon'ble High Court against the order of the Committee with regard to the regulation of fee structure for the academic years 2017-18, 2019-20 & 2020-21. The Hon'ble Court, by common judgment referred to as 4th paper above, ordered that the matter pertaining to the regulation of the tuition fee shall stand remanded to the Committee for reconsideration as provided in the Act 15 of 2017 and the directions of the Apex Court in various judgments.
3. In due compliance of the above direction, the Committee reconsidered the matter and issued orders, referred to as 5th paper to 7th papers above, thereby regulating the fee structure in respect of the Medical College from the academic years 2017-18 to 2020-21.

4. Thereafter, the Principal of the Medical College, by communication referred to as 8th paper above, submitted a representation before the Committee requesting to reconsider the regulation of tuition fee for the academic years 2021-22, 2022-23 & 2023-24 on the basis of the revised order issued by the Committee vide reference cited 7th paper above.
5. Details of tuition fee already regulated by the Committee are given hereunder:

6. In the meeting held on 15.05.2024, Committee took notice of the fact that fee regulation orders were issued by granting hike in tuition fees and other fees based on CPI of the immediately preceding years for the academic years 2021-22, 2022-23 & 2023-24. Hence, nothing stood in the way of revising the fee structure vide orders referred to as 1st to 3rd papers on the basis of the order referred to as 7th paper above.
7. It is pertinent to note that the Committee had already regulated the special fee and other fees to be collected from the MBBS students and

that the same is not in dispute. Hence, the special fees, other fees and NRI fees will continue as such for the afore academic years also.

8. In view of the fact stated above, Committee hereby revise the fee regulation order relating to 2021-22, 2022-23 & 2023-24 batch of students as follows:

9. Accordingly, the tuition fee fixed earlier vide references cited 1st to 3rd papers above, are revised by the Committee as shown in the Annexure given below. Amount, if any, received by the Medical College from the students in excess of fee revised by the Committee shall be refunded to the students. Similarly amount, if any, due from the students as balance fees shall be paid by the students to the Medical College.

- 10.** The Principal of the Medical College is permitted to collect the tuition fee, the special fee and other fees as given in Annexure I, II & III given below, from the students of MBBS Course who have taken admission in the academic year 2021-22, 2022-23 & 2024-25.
- 11.** Needless to say that the Principal of the Medical College shall collect only the approved fee from the students of MBBS Course. The Medical College shall not collect, either directly or indirectly, any other amount from the students over and above the amount fixed as fee as per this order. If any amount is charged under any other head or pretext, the institution will be liable to face penal action as per the Rulings of the Apex Court and the provisions of Act 15 of 2017.
- 12.** The Principal of the Medical College is directed to collect from the students, the approved tuition fee and special fee through online payment/ cheque/DD/RTGS/IMPS only.
- 13.** Email copy of this order to the Government of Kerala and the Principal of PK DAS Institute of medical Sciences, Vaniamkulam P.O, Ottapalam, Palakkad. The Government of Kerala may notify the fee structure as per Annexure II given below for the academic year 2024-25, as per section 9 (2) of Act 15 of 2017.
