

Undertaking in Rs.200/- Stamp Paper

1. I undertake to pay the tuition fees and hostel fees as prescribed/notified by the Institution or competent authorities at the time of admission.
2. I hereby agree and undertake to pay the tuition fees and hostel fees as per the notified fee structure issued by the Institution/competent authorities before the commencement of each academic year or within the prescribed due dates.
3. I undertake to pay hostel fees and mess/transportation fees annually at the time of admission or as prescribed, if applicable.
4. I acknowledge that all fees must be paid within the stipulated time as notified by the institution, failing which I shall be liable for penalties and other consequences as determined by the Institution.
5. I agree that I shall pay any additional or differential fees arising due to revision or enhancement by any statutory authority, regulatory body, Government authority or pursuant to orders of a competent court.
6. I understand and agree that all fees once paid are non-refundable and non-transferable under any circumstances, including discontinuation of the course.
7. I acknowledge that I may not be eligible for scholarship benefits or may forfeit such benefits if I fail in any subject, as per applicable rules.
8. I understand that I will not be permitted to appear for university examinations if there are any outstanding fee dues.
9. I agree to pay a late fee/penalty at the rate of 12% (twelve percent) per annum or such rate as may be prescribed by the Institution from time to time for any delayed payments.
10. I further undertake to pay any additional fees as may be fixed by the Institution and/or any competent authority, if such fees exceed the amount already paid.
11. I hereby undertake that I shall apply for and obtain the Transfer Certificate (TC) or any equivalent academic/exit document only after fully clearing all outstanding dues payable to the Institution. I further acknowledge and agree that the Institution shall have the absolute right to withhold issuance of such certificate/document until all dues are settled in full.
12. I hereby agree and acknowledge that in the event of my voluntary discontinuation, withdrawal or termination of the course for any reason whatsoever, before completion of the prescribed duration of the programme, I shall be liable to pay liquidated damages to the Institution. Such liquidated damages shall be equivalent to the total tuition fees and any other applicable fees payable for the remaining period of the course, along with any outstanding dues, arrears, penalties or other charges payable to the Institution up to the date of such discontinuation.
13. I further agree that the said amount represents a genuine pre-estimate of the loss that may be incurred by the Institution on account of my discontinuation and is not in the nature of a penalty. I undertake to pay such an amount on demand by the Institution, without demur or delay.
14. I understand that failure to comply with any of the terms of this undertaking shall render me liable for appropriate legal, academic and disciplinary action, including but not limited to suspension or discontinuation of my course.
